

Electronic Version of Informed Consent for the collection of personal contact details for list sales use of CPA Examination Services

NOTICE: THIS CONSENT IS A BINDING CONTRACT BETWEEN YOU AND YOUR STATE BOARD OF ACCOUNTANCY (THE "STATE BOARD") AND ITS DESIGNEE, THE NATIONAL ASSOCIATION OF STATE BOARDS OF ACCOUNTANCY ("NASBA"). HOWEVER, IF, AT ANY TIME YOU ATTEMPT TO REVOKE YOUR CONSENT, EITHER DIRECTLY, OR BY CHALLENGING THE ENFORCEABILITY OF ANY PART, YOU WILL NO LONGER BE ALLOWED TO UTILIZE CPAES SERVICES.

I agree that my personal contact details may be collected, received, transferred, stored, and processed in connection with utilization of NASBA services. Such information may be used and disclosed by NASBA and transmitted as necessary to release your name and address to CPA Review Course providers, public accounting firms, and other professional organizations of CPAs.
