## New Year; Here's the Plan!

Happy New Year to everyone! The legislature is now in session and we have several important things taking place this year. First, the agency will undergo a Sunset review to authorize the Board to continue the regulation of our profession. Second, we are cleaning-up obsolete language in our statute regarding references to bi-annual registration. Finally, we have proposed changes to our statute and rules. The biggest item, which I addressed last year, is the proposed fee increase. While the Board has some of the lowest fees in the country, we last raised our fees twelve years ago and the cost of doing business and need for system upgrades has caught up with us. Other proposed changes include:

- Removing the Oklahoma residency requirement from the "designated manager" definition, while still requiring the managing partner to hold a valid Oklahoma CPA certificate;
- Allow CPAs, who have a "canceled" or "revoked for failure to register" status greater than five years, to be reinstated without retaking the CPA exam;
- Allow fee waivers for low-income individuals to comply with state statute;

- Allow CPE reciprocity for those registrants who reside and are certified in another jurisdiction;
- Create a "retired" certificate status and fee waiver for our registrants who are retired from all forms of employment;
- General clean-up in the peer review area.



These revisions are in line with other state boards of accountancy rules and will benefit our registrants. If you have any questions regarding the proposed statute or rule changes, please give me a call.

## Are you receiving our notifications?

Many of our registrants choose to use their employer's address, phone number, and email as their contact information in their OAB record. This is fine in most cases, because after all, that is where we spend most our days. However, it becomes an issue when there is a change in employment and contact information fails to get updated. To avoid any lapse in communication, the Board suggests designating your home addresses, cell phone number, and personal email as your primary contact. Additionally, it's a good idea to verify that our email notifications are not going to your spam file and please don't opt out of our notifications. Let's make it a goal to stay more informed this year!



## Registration – “I didn’t complete CPE hours...”

I make courtesy calls monthly to remind CPAs who are in lapsed status that they are about to be revoked for failure to register. More often than not, I hear the following: “I didn’t complete all of my CPE, so I will just wait until I get caught up to renew my certificate” or “I can’t register my certificate because I didn’t complete enough CPE hours.” This is not the case! You can still register your certificate. While all registrants are required to comply with CPE, unless exempted, in many cases registrants are eligible to make-up the CPE hours they are short. The Board will later address any penalties or disciplinary actions that may be a result of a CPE deficiency as these situations are handled on a case-by-case basis. Alternatively, if you let your CPA certificate revoke, it takes many options off the table and you are subject to the reinstatement process. Please register when it is time to register. Don’t make a tough situation a lot worse. Please contact the Board should you have any questions or to discuss how we can help you.

# Introducing NASBA's 2018-19 Chair, Janice L. Gray, CPA

NASBA is pleased to announce Janice L. Gray, CPA, of Norman, OK, as chair of its 2018-19 Board of Directors. Gray, along with a slate of newly elected board members, was installed into office during NASBA's 111th Annual Meeting, held in Scottsdale, AZ.



In Gray's own words, she did not take the "traditional" path to get to where she is today. While on her path to pursuing her accounting degree, she encountered many obstacles. But it was her perseverance and determination that helped her to succeed. During Gray's inaugural address, she discussed the need for examining the four (4) E's of the accounting profession, diversity and the history of peer review. Below is a brief overview of her address:

1. The 4 E's (Education, Exam, Experience, Ethics): Education is the first hurdle to becoming a CPA. There are new educational challenges facing CPAs, primarily in technology: bitcoin, blockchain, data analytics and artificial intelligence. According to Gray, the time to develop new skill sets is NOW.

Previously, the Exam was a pencil and paper test given twice a year, with results snail-mailed to candidates three months later. Today, candidates may sit for the Exam when it is more convenient for them and can expect to see their results within a few weeks. Times are changing, and with the rapid changes in technology, regulators must decide

how often the Exam requires updating to stay relevant.

The experience requirement is widely discussed within the profession – how much experience should be required to obtain a license? Gray states that regulators must remain engaged for the evolution of the profession. Now is the time to review necessary skill sets and determine appropriate changes to the experience requirement.

The AICPA's Code of Conduct, which calls for "an unwavering commitment to honorable behavior," has been adopted by 30 jurisdictions in some form, but there are many jurisdictions that have not yet adopted the Code. Gray suggests there may be a need to incorporate appropriate language changes to the current Uniform Accountancy Act.

2. Diversity: We must encourage minorities, including women and people of color, to become more involved in the regulation of accounting. Gray believes if diversity had not been an initiative for NASBA, she would not be where she is today.
3. Peer Review: Once Gray began serving at NASBA, she discovered her niche – peer review. Her belief is there must be open communication between the Compliance Assurance Committee (CAC) and the Peer Review Board in order to efficiently resolve issues, avoid conflict and achieve open transparency. ★

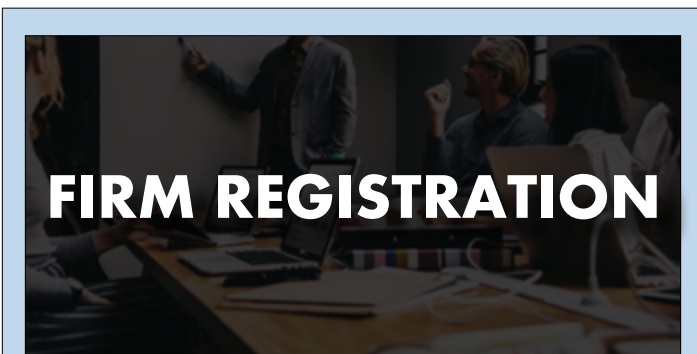

It is finally here! After two years of delayed score releases, due to updating and upgrading, the AICPA has issued a timeline of four score releases per Window. Also, do not forget that Oklahoma candidates now have the ability to see their score in their NASBA record on the day it is released.

- If you take the BEC section, you might receive your score approximately one week following the target release date due to additional analysis that may be required for the written communication tasks.
