COLORADO INFORMATION FOR PRE-EVALUATION

The Colorado State Board of Accountancy (Board) has engaged Compliance Services (a division of the National Association of State Boards of Accountancy) for application processing, credential evaluation, examination administration, and grade reporting. Please read this information before completing the application form.

PURPOSE

A pre-evaluation will identify academic deficiencies in a candidate's education prior to submitting an initial application for CPA Licensing in Colorado. Pre-evaluations are advisory in nature and are not a final determination of eligibility.

A pre-evaluation allows a candidate to correct academic deficiencies prior to submitting an initial application for the Licensing.

Pre-evaluations are valid only for the current requirements, and for the State of Colorado. Should the requirements change prior to final application and acceptance, the pre-evaluation will be considered null and void. Pre-evaluations are based solely on the information provided by the candidate. Should the information prove to be inaccurate in any way, the pre-evaluation will not be considered valid.

Completed pre-evaluation applications and all required materials must be submitted to Compliance Services.

APPLICATION FEES

Pre-evaluation application: \$50

All fees must be in U.S. dollars. Certified Checks or money orders must be drawn on a U.S. bank and made payable to Compliance Services.

Application fees are **NON-REFUNDABLE**. Fees paid for pre-evaluation do not apply or carry over to Colorado Initial Application for Colorado Licensure.

EDUCATION REQUIREMENTS FOR COLORADO LICENSURE

Applicants must have earned a baccalaureate degree and completed all required courses at academic institutions accredited by one of the six U.S. regional accrediting bodies.

Rule 2.4 Requirements (Qualifying under Education and Experience)

a bachelor's degree;

24 semester hours in accounting;

3 semester hours in audit;

21 semester hours in general business subjects, with no more than 6 hours in any subject;

All applicants residing inside the United States or relocating to the United States must complete an Affidavit of Eligibility to determine legal presence in the United States;

NOTICE: 12 months of full-time work experience in public accounting or the equivalent <u>must be fulfilled prior to applying for</u> <u>licensure</u>. The experience must include 1800 hours of qualifying experience under the supervision of an active CPA in good standing or a Chartered Accountant in good standing. The experience must be obtained five years before or after passing the exam; and pass the AICPA ethics exam

Rule 2.5 Requirements (Qualifying under Education in Lieu of Experience)

a Masters degree, doctoral degree, or a bachelor's degree with 30 additional hours;

39 semester hours in accounting;

6 semester hours in audit;

36 semester hours in general business subjects, with no more than 9 hours in any subject; and

All applicants residing inside the United States or relocating to the United States must complete an Affidavit of Eligibility to determine legal presence in the United States;

NOTICE: Experience is not required when applying under Rule 2.5.

LETTER OF DETERMINATION

A letter of determination will be mailed to pre-evaluation applicants approximately two to four weeks after receipt of the pre-evaluation application.

MATERIALS TO BE SUBMITTED

Pre-evaluation applicants must submit to Compliance Services:

- 1. Completed, signed pre-evaluation application;
- 2. Fee payable to Compliance Services; (All fees must be U.S. dollars. Certified checks or money orders must be drawn on a U.S. bank)
- 3. Official transcript(s) and/or foreign credential evaluations (copies are not acceptable).*

ALL DOCUMENTS MUST BE ADDRESSED TO THE COMPLIANCE SERVICES DEPARTMENT.

*PLEASE NOTE: Compliance Services does not evaluate foreign transcripts. If you have earned academic credit outside the U.S., you must submit all foreign transcripts to a foreign credential evaluation service such as the Foreign Academic Credentials Service, Educational Credential Evaluators, Inc., or any other member organization of NACES (National Association of Credential Evaluation Services, Inc.) Candidates should obtain the form to request this service from the evaluation service.
