Verification of Experience Institute of Chartered Accountants of Scotland

Candidates for the International Qualification Examination (IQEX) are required to have completed an additional 2 years of relevant work experience after obtaining the CA credential and being admitted to membership in the Institute of Chartered Accountants of Scotland (ICAS). This experience may be verified by a direct supervisor in those cases where ICAS is not able to confirm the experience has been completed.

This Verification of Experience is valid for the IQEX only. After you pass the IQEX and are ready to apply for licensure as a Certified Public Accountant in the U.S., you will need to follow the licensure application process for the state to which you apply for licensure. This may include a new verification of experience.
