We have been processing renewals for almost a month now.

A reminder that renewals are due June 30. All CPE must be completed by June 30. Keep in mind if you took advantage of the extension the Board granted last year you cannot submit those same hours for this year. If you have questions regarding your renewal, please reach out to either myself or Pene at the North Dakota State Board of Accountancy office.

Lastly, please remember that July 1st starts the new CPE rules. All CPAs who wish to hold out must have 120 hours of CPE by June 30, 2022. This number based on a 3-year rolling period. You also need 6 hours of Ethics over the same period of time. The Board does not limit the amount of self-study a licensee can participate in.

Annual Renewal Season

The 2020-2021 annual license renewal and CPE reporting season is up and running. As renewals roll in there are several questions CPAs are asking. Here are a few frequently asked questions as you get ready to renew your license and report CPE.

Q: Not all of my CPE will fit on the form provided online. What do I do?

A: If you have several courses to report you can email a spreadsheet or PDF listing of your courses to Pene DeMaster at pdemaster@nd.gov

Q: I keep getting an error when my credit card is processing.
Why won't it process?

A: There could be a million answers to this question but most of the time if you try a different browser your credit card will process. Please email Pene to get the link directly to the payment page so you do not have to submit another registration form.

Q: If I took classes that I did not report last year can I add them this year?

A: Absolutely! Send an email to Pene to let her know which course(s) you would like to add. Keep in mind you cannot carryover CPE. It must be reported in the year it was earned (except for last year's Covid-19 extension).

Q: Do I need a firm permit even if I only prepare tax returns for a few people?

A: If you sign tax returns as a CPA you must, 1. hold out for public accounting and 2. obtain a firm permit from the North Dakota State Board of Accountancy.

Q: If I seek retirement status is it permanent and do I have to continue to renew my license?

A: Retirement status is not permanent. There is the option to reinstate if you decide to go back into the office. The staff at the Board of Accountancy office can help you with the process. Once you are in retirment status you do not have to continue to renew your license. You are allowed to use the CPA designation after your name but must include "retired".

Q: I heard something about a rule change next year. Can you tell me more about the new requirements?

A: The 2018 Rule Change will increase CPE Requirements for those who check the box "all others who hold out as a CPA in North Dakota". Beginning with the July 1, 2021 to June 30, 2022 three year look back the requirement will increase to 120 credit hours of acceptable CPE in the immediately preceding three reporting periods and at least 20 credit hours each year including 6 credits of ethics over the same period.

For those who hold out for public accounting there is a new requirement of 6 ethics credits beginning with the July 1, 2021 to June 30, 2022 the three year look back period.

Q: Is the requirement 6 ethics credits per year?

A: No, the requirement is 6 ethics credits over a rolling 3 years.



This Just In!

Due to increasing travel restrictions Prometric has expanded international testing for a second time. Qualified candidates may begin applying to take any section of the U.S. CPA Exam and may also begin scheduling their Exam with Prometric as of May 5, 2021. Candidates will write the Exam at the Prometric test centers in Tel Aviv, Israel, and in Riyadh, Jeddah and Khobar, Saudi Arabia.

In order to test in Israel and Saudi Arabia, as well as the other Middle East countries where testing is currently available (including Bahrain, Kuwait, Lebanon and the United Arab Emirates), candidates must be eligible CPA Examination candidates with valid citizenship or long-term residency in one of the following countries:

Bahrain Pakistan Egypt Qatar

India Saudia Arabia Israel United States

Jordan United Arab Emirates

Kuwait Yemen

Lebanon Oman
