William H. Van Rensselaer Public Service Award

Donald H. Burkett, CPA, of West Columbia, South Carolina, is a 1974 graduate of the University of South Carolina and has over 48 years of public accounting experience. He is the former president and current vice president of the firm of Burkett Burkett & Burkett Certified Public Accountants, P.A., with offices throughout South Carolina.

Mr. Burkett serves as chair of the NASBA Center for the Public Trust (CPT) Board of Directors, and is a past chair of the National Association of State Boards of Accountancy (NASBA), 2015-16. Mr. Burkett has held numerous leadership positions as a member of NASBA's Board of Directors, including Middle Atlantic regional director and NASBA vice chair, 2014-15. Currently, he is a member of NASBA's Past Chair Advisory Council and Diversity Committee. He is also a member of NASBA's Ethics Committee. Since 2007, Burkett has been an active member of NASBA and chaired several NASBA committees including NASBA's Awards, Legislative Support, Audit, Ethics and Relations with Member Boards Committees.

Prior to becoming CPT chair, he served as a member of the NASBA CPT Board of Directors, and on NASBA's Communications Committee, Administrative and Finance Committee, Nominating Committee, International Qualifications Appraisal Board and the Standards Study Group. Mr. Burkett is a former chairman, vice chair, secretary and member of the South Carolina Board of Accountancy. He serves as chair of Lexington Medical Center and has been a board member since 2017. Mr. Burkett is a member and past president of the South Carolina Association of CPAs and a member of the American Institute of CPAs' Vision Project Team. He is the past president of the Cayce/West Columbia Civitan Club and the Rotary Club. Additionally, Burkett is the president of Airport High School Educational Foundation.

NASBA Distinguished Service Award

John "Jack" Dailey, Jr., CPA, RMA, PSA, of Voorhees New Jersey, was a retired CPA partner at Bowman & Company LLP in Voorhees Township, New Jersey, at the time of his passing on June 23, 2022, at the age of 71. Most recently, Dailey served as a member of the National Association of State Boards of Accountancy (NASBA) Board of Directors as director-at-large and as chair of NASBA's Legislative Support Committee. He was a former Northeast regional director of NASBA and a former chair of NASBA's CPE, Relations with Member Boards and Peer Review Compliance Committees.

A member of the New Jersey Society of Certified Public Accountants (NJCPA) since 1978, Dailey is a past president of the NJCPA, a past president of the Southwest Jersey Chapter and the recipient of the 2021 NJCPA Lifetime Leader Award. He was also a participant in numerous accounting interest groups and committees and a highly regarded presenter and author.

Mr. Dailey was appointed to the New Jersey State Board of Accountancy by three governors and served as its president from 2013-15. As a member of the American Institute of CPAs, he served on the AICPA Council and Professional Ethics Executive Committee from 2010-13. Additionally, Dailey was a member of the New Jersey Registered Municipal Accountants Association.

In 1973, Dailey earned his Bachelor of Science in Business Administration from Villanova University. He was a lover of Villanova basketball, an avid fan and season ticket holder. Mr. Dailey also loved spending summers in Ocean City, New Jersey with family and taking family vacations to Walt Disney World. He was a dedicated husband, father, grandfather, brother, friend and member of the accounting profession.

As a lasting tribute to his love of the profession and support of the next generation of CPAs, the NJCPA has established a scholarship in his honor.

PATTI BOWERS

Lorraine P. Sachs Standard of Excellence Award

Patti Bowers of Sacramento, California, serves as the executive officer of the California Board of Accountancy (CBA), where she was selected for her role in October 2008. A 23-year veteran of the CBA, Bowers also served as supervisor in the Enforcement Division and chief of the Licensing Division.

Prior to joining the CBA, Bowers began her career in state civil service as a sworn peace officer with the California Department of Corrections and Rehabilitation, Division of Juvenile Justice. Prior to joining state civil service, she worked in Sicily as a supervisor for the U.S. Department of Defense. Ms. Bowers also worked as an academic coordinator while attending the University of Maryland's European Division in Iceland.

As executive officer of the CBA, Bowers has overseen the adoption and implementation of significant consumer protection policies in California including mandatory peer review, enhanced continuing education requirements, enactment of mobility, modifications to the licensure framework, and rigorous enforcement policies. She has also overseen high-level of engagement with public stakeholders, undertaken CBA operational efficiencies, initiated outreach to consumers, licensees, and candidates, and has professionally represented the CBA before policy leaders on numerous accounts. Additionally, Bowers has supported the personal and professional development of her staff at the CBA by providing opportunities to grow skills and advance into new roles, which has led to a highly capable and respected team.

In addition to her day-to-day duties at the CBA, Bowers has participated in a number of NASBA committees and taskforces that have worked to help support Board of Accountancy operations across the country. These entities include NASBA's ALD Committee, Accountancy Licensee Database/CPAverify Committee and Strategic Planning Task Force. She also participates in a number of committees, taskforces, and other trainings with the Department of Consumer Affairs, which oversees the CBA and other consumer protection boards and bureaus.
