



THE CHAIR'S CORNER: Are we headed back to the future?

At our March Board meeting, a lively discussion was held regarding proposed legislation by the Minnesota Society of CPAs (MNCPA) concerning the 150-hour education requirement. Some professionals believe this legislation could be the end of the 150-hour education requirement. Or, as discussed at our meeting, could it be a potential race to the bottom? No matter what our individual interpretations are, Minnesota has certainly ignited the discussion.

In their response to a *Journal of Accountancy* article from February 10, 2023, titled "NASBA upholds 150-hour education requirement for CPA licensure." Minnesota laid out their case for the proposed legislation. Their response can be found on the MNCPA website via a February 27, 2023, post by Linda Wedul, CEO of MNCPA. That post noted the undisputed current pipeline crisis, as well as the potential hurdle to licensure created by the 150-hour rule. It made clear that the goal of the legislation was not intended to lower the bar for licensing but rather to create additional quality pathways to licensing. The article from MNCPA states:

The Minnesota Society of CPAs introduced legislation to broaden the path to CPA licensure in Minnesota. All options require passing the CPA exam and an ethics exam. The options include:

- 150-college credit hours with one year of experience. This is the current requirement.
- 2. 120-college credit hours with an accounting degree or equivalent with two years of accounting experience. This would be a new, additional pathway.
- 120-college credit hours with an accounting degree or equivalent, one year
 of experience and 120-continuing professional education credits within one
 year of licensure. This would be a new, additional pathway.

As with any legislation, no one will be able to accurately assess its effects, whether intentional or unintentional, until years after should it pass and become law.

Currently, in Florida there does not appear to be an outcry to modify our licensing requirements. However, it may be beneficial to consider the history of the 150-hour education requirement, as well as the current

professional environment, to ensure we understand how and why this rule came to be in Florida.

Thanks to the FICPA, we have a wonderful book available to review the history of public accounting in Florida titled, 100 Years of Service to the Certified Public Accounting Profession in Florida. Shelly Weir, the current FICPA President and CEO, was kind enough to share the book and specifically the section on Florida's implementation of the fifth-year/150-hour education requirement.

It's clear in reviewing this history that there was an extremely thoughtful process that went into adopting the fifth-year/150-hour rule, starting with discussion as early as the late 1960s through its adoption in 1983. Florida clearly was a trailblazer on this issue. While these requirements were discussed nationally, during this process, the FICPA and Florida Board of Accountancy members had the forethought to realize that the CPA profession is a constantly evolving one. With multiple standards and regulatory setters, CPAs are constantly challenged to stay current, both with standards and regulations, as well as with the related technical tools required to provide the highest level of service to the public.

The issues that faced these trailblazers in the late 1960s through adoption of the rule, such as increased starting salaries, reduction in accounting graduates, and mobility, among others, remain as relevant today as they did then. No matter what happens in Minnesota, we need to be mindful of our past and understand how we arrived at this rule. We should also be proud of Florida's leadership role in implementing the fifth-year/150-hour education requirement and use it as our example as we evaluate the future of licensing in Florida.



Director's Message: Noise in the System

On a national level, there has recently been a lot of communication regarding what should be the required time period for passing the Uniform CPA Examination (the Exam). This "noise in the system" is based on a set of short-term challenges involving the transition to the new Exam. A longer-term challenge is a national shortage of CPAs, or what the profession commonly refers to as a

"pipeline issue." While the Florida Board of Accountancy's primary mission is protecting the public, the Board seeks to be part of the solution for both these challenges.

Currently, the standard requirement is 18 months to pass all four sections of the exam. What is commonly referred to as the "18-month Rule," has been in effect since the exam moved to computer-based testing.

As part of the CPA Evolution initiative, the CPA Exam will be changing significantly in January 2024. The new format still involves four sections, but it will be comprised of three required **CORE** sections and one selected **DISCIPLINE** section.

The required **CORE** sections cover:

- Auditing and Attestation (AUD)
- Financial Accounting and Reporting (FAR)
- Taxation and Regulation (REG)

The **DISCPLINE** options are:

- Business Analysis and Reporting (BAR) or
- Information Systems and Controls (ISC) or
- Tax Compliance and Planning (TCP)

The **Disciplines** focus on topics that apply to newly licensed CPAs engaged in those areas of practice and are less likely to be encountered by newly licensed CPAs who do not focus in those practice areas.

In conjunction with this change in the Exam forma, the AICPA has published a tentative testing schedule and score release schedule. The testing schedule includes significant black-out periods when candidates will not be allowed to test. The score release dates are also delayed. The following is the AICPA's tentative schedule:

Short-Term Solution

Due to the limited testing schedule and delayed score releases in 2024, the Florida Board of Accountancy recognized the increased challenge for exam candidates. In response, the Board adopted a rule change effective May 14, 2023. Rule 61H1-28.0052 (4) F.A.C extends examination credits expiring between January 1, 2024 and June 29, 2025, to June 30, 2025. This change should provide significant relief to Exam candidates testing in 2024.

Long-Term Solution

With the reduction of candidates in the pipeline and the increased workload of firms, there has been increasing interest in providing exam candidates and firms relief by extending the exam period.

On April 24, 2023, the National Association of State Boards of Accountancy (NASBA) announced the adoption of an amendment to the Uniform Accountancy Act Model Rules pertaining to the Exam. In part, NASBA's amendment recommends that state Boards of Accountancy extend the window for passing the CPA Exam from 18 months to 30 months. This amendment does not have a sunset and is considered a more lasting change. The amendment to the UAA Model Rules has no immediate effect on Florida Board rules. Each state board may consider the amendment and decide whether to change the rules at the state level. Current Florida exam candidates remain under existing rules until, if and when, the Florida Board makes changes.

The Florida Board plans to consider the amendment, determine how to implement the changes, and commence the process to change the rule at the state level. The Board and the CPA Division staff will strive to communicate any changes when they go into effect.
