## Rule Change Summary

Effective April 1, 2024, the following rules take effect:

All CPA licenses and firm permits must be renewed by June 30. A late fee of \$100 will be applied on July 1. On August 1 any licensee or firm who has not completed their renewal will be involuntarily relinquished. A new "CPA, Inactive" status is offered on the license registration form in Certemy. This status is for those who perform NO compensated accounting, auditing, management, or financial advisory, consulting, bookkeeping, or tax services may use the title CPA, inactive. See rule 3-02-02-05 for complete details.

### Annual CPE Audit

A record of attendance or completion is now the only accepted as proof of attendance. Registrations, slide shows, class paperwork are no longer acceptable proof of attendance.

### CPA Exam Changes

There is no longer a limit of Economics credit accepted toward the business concentration.

Candidates now pay a one-time \$120 initial exam application fee, and each notice to schedule is only valid for 6 months rather than 1 year. A re-application or re-application fee is no longer required.

Exam credit is valid for 30 months rather than 18 months. This will begin from the score release date. The full rules document is available at <https://www.ndsba.nd.gov/accounting-law-rule>

## Time to Renew!

It's that time of year again! Time to renew your license and report your continuing professional education. Keep in mind the new rule changes are in effect for this renewal season.

The change that will make the biggest impact is the grace period for late renewals and reporting. All licenses, firm permits, and CPE reporting is due June 30 each year. In that past the board allowed a grace period from July 1 to July 31 to renew without a late fee or penalty adding the late fee on August 1 and finally involuntarily relinquishing any non-renewal by September 1. The 2024 Rule Change no longer allows that grace period. All license and firm renewals and CPE reporting are due by June 30 this year. A late fee will be applied on July 1 and on August 1 any license or firm permit that is not renewed will be involuntarily relinquished and must go through the reinstatement process to regain licensure.

The second important change is what is acceptable proof of completion of CPE. A registration is no longer acceptable as proof of completion. Formal evidence of course attendance or completion, and written records of course sponsorships, titles, dates, times, locations, and instructors must be provided, as required by the Board.

Acceptable records:  
An attendance record from the course  
A certificate of completion from the vendor

Records that are not acceptable:  
Registration confirmations  
Power Point presentations/slides  
Conference pamphlets  
Unverified agendas

Inactive:  
An inactive status will be added as a choice in the license registration workflow this year. Inactive status is available for a CPA or LPA who performs no compensated accounting, auditing, management, or financial advisory, consulting, bookkeeping, or tax services. An inactive certificate holder or licenseholder may not practice in this state but may use the title "certified public accountant, inactive" or "licensed public accountant, inactive" or the abbreviation, "CPA, inactive" or "LP, inactive" as applicable.

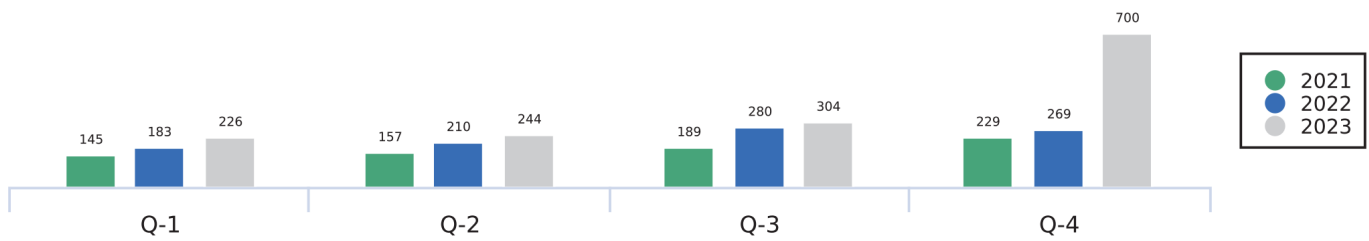

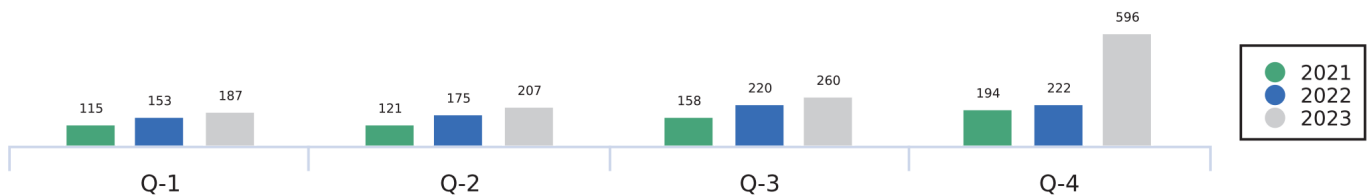

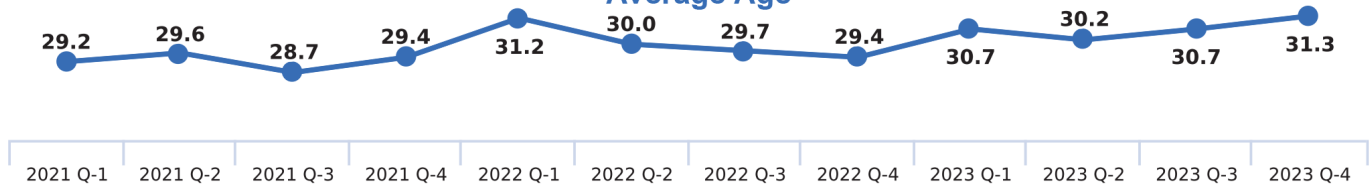
